**Board of Adjustment-** A Recommending Board to the Commission, anyone interested should have a knowledge of Planning, Zoning, and Technical codes. Hear cases such as Appeals to Building Official decisions, Variance Requests, etc.

**CME/ Scenic Highway Committee-** A Advisory Board to the Commission, anyone interested in enhancing Gulf Drive (789) is welcome to be on this committee.

**Planning & Zoning Board-** A Recommending Board to the Commission, anyone interested should have a knowledge of Planning and Zoning. Hear cases such as Special Exceptions, and Major Development Applications.

**Code Enforcement Board-** A Quasi- Judicial Board, they do not make any recommendations to the Commission. The board hears cases for Residents or Business Owners who have not come compliant with the Land Development Code.

**Citizens Advisory Committee to the Comprehensive Plan & Land Development Code (CAC-CP/LDC)-** This Advisory Committee to the Commission to review and make changes to the Comprehensive Plan and Land Development Code.

**Community Redevelopment Agency Committee(CRA)-** A Advisory Committee to the Commission on suggestions on how to spend funds available to enhance the CRA District.

**Charter Review Committee (CRC)-** A Advisory Committee to the Commission on reviewing the City Charter and suggesting any recommended changes.
